Also to thank Tony and his team of green keeping staff for their hard work, which gives us a course to be proud of. A thank you to Rodney our pro, for all his hard work again over the last 12 months. And of course a thank you to all our members for continuing to choose to play at Silverstone Golf Club (2005) Ltd

The Steering Committee have set out a 2 year plan for continuing to make improvements to the course.

Finally, when you renew your membership, your renewal membership card will allow you to transfer money on to your card, so that it can be used as a payment card in the Proshop and the clubhouse bar. Any competition winnings will be transferred directly on to your membership card. This facility will be available from April 2022.
